

PVC GROUP ACTIVITY FACILITY RENTAL CONDITIONS

1. The club must be notified of all organized parties, even those consisting of less than 20 people. Any party consisting of 10 or more people must also fill out a PVC Facility Rental Agreement. This rule is in effect throughout the year. All PVC party requests must have prior approval of date before Rental Agreements are sent to the business office. Please confirm with the business office that the date you wish to have your party is available. **Any unauthorized party will be assessed all applicable fees.**
2. There will be no organized group of more than 70 people (swimming and non-swimming) renting any part of the facility, other than PVC sponsored activities.
3. Fees:

Groups of 10-20 people: \$50.00 use fee, Lifeguard rate of (\$15) for one lifeguard. Should the event go beyond the time specified in the rental agreement, the lifeguard hourly rate will go to overtime (2x the normal rate.) If the number of guests goes over 20, the higher rate will be charged.

Groups of 21-40 people: \$75.00 use fee, and the hourly rate for two lifeguards (\$30). Should the event go beyond the time specified in the rental agreement, the lifeguard hourly rate will go to overtime (2x the normal rate). If the number of guests goes over 40, the higher rate will be charges.

Groups of 41-55 people: \$125.00 use fee, and the hourly rate for three lifeguards (\$45). Should the event go beyond the time specified in the rental agreement, the lifeguard hourly rate will go to overtime (2x the normal rate). If the number of guests goes over 40, the higher rate will be charges.

Groups of 56-70 people: \$175.00 use fee, and the hourly rate for three lifeguards (\$45). Should the event go beyond the time specified in the rental agreement, the lifeguard hourly rate will go to overtime (2x the normal rate). No parties are authorized to have more than 70 guests.

Lifeguards. All group events require lifeguard(s). This applies during guarded and key hours. The lifeguard must be a PVC employee. The guard is assigned to ensure the safety of participants as well as to enforce PVC rules and regulations. One guard will be employed to work 30 minutes prior to arrival of guests and 30 minutes after. The lifeguard is there to assist you in preparing for your guests
4. A 48-hour cancellation notice to the Business Manager is required for a full refund. Any less than 48 hours will result in a \$25.00 fee. All refunds will be via a Pleasanton Valley Club check.
5. The club reserves the right to limit the number of parties taking place on the same day.
6. **Any unauthorized party will be assessed all applicable fees.**
7. Groups may reserve the lanai area or the barbeque area but not both. When you reserve an area, you are required to share it with the general membership.

8. The applicant is responsible for its party members. The applicant should review the safety rules and regulations to ensure their guests are aware of them. The PVC member must remain on the premises while any non-PVC guests are on the premises.
9. The Facility Rental Agreement is non-binding until the application and fees are paid. All fees must be paid at the time of application.
10. The Pleasanton Valley Club has no legal or financial obligation to any person injured while attending a private party on PVC grounds.
11. In case of inclement weather or other unforeseen emergency, the applicant agrees to abide by the decision of the PVC President or in his/her absence, the PVC Vice-President on whether to cancel the Facility Rental Agreement.
